TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), is entered into effective as of October 20, 2014, between Redi-Mix, LLC, a Texas limited liability company ("Assignee"), and Oldcastle Building Products Inc., a Delaware corporation ("Assignor").

For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, each party hereby agrees as follows:

1. **Acquired Intellectual Property.** Assignor hereby sells, transfers, grants, conveys, assigns and delivers to Assignee all of Assignor's right, title and interest in and to the trademark listed in Appendix A hereto, together with all goodwill associated therewith and symbolized thereby and all applications and renewals in connection therewith (the "Assigned IP"), and all causes of action, enforcement rights and claims for damages, whether currently pending, filed, or otherwise, for the Assigned IP, including all rights to damages, injunctive relief and other remedies for past, present or future infringement, dilution or misappropriation of the Assigned IP.

2. **Further Assurances.** From time to time, as and when requested by Assignee, Assignor will execute and deliver, or cause to be executed and delivered, all such documents and instruments as may be reasonably necessary to consummate and fully effectuate the transactions contemplated by this Assignment.

3. **Subject to Purchase Agreement.** This Assignment is subject to the terms and conditions of the Purchase Agreement. No provision of this Assignment shall be deemed to amend the terms or provisions of the Asset Purchase Agreement, dated October 20, 2014 (the "Purchase Agreement"), between Oldcastle APG West, Inc. and Ashley Acquisition, LLC (each an affiliate of Assignor) and Assignee. Notwithstanding anything to the contrary set forth herein, if there is any conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall control.

4. **Counterparts.** This Assignment may be executed in any number of counterparts, all of which when taken together shall constitute one and the same instrument. This Assignment may be executed on signature pages exchanged by facsimile or other electronic means, in which event each party shall promptly deliver to the others such number of original copies as the others may reasonably request.

5. **Successors and Assigns.** This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

6. **Governing Law.** This Assignment shall be construed under and enforced in accordance with the laws of the State of New York.


