**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 2, 2014 by MADISON CAPITAL FUNDING LLC, as Agent for the Lenders (the “**Agent**”).

W I T N E S S E T H:

WHEREAS, Agent and PROREHAB, P.C., a Missouri professional corporation (“**Grantor**”) were parties to that certain Trademark Security Agreement, dated as of December 30, 2010 (the “**Agreement**”; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 30, 2010, at Reel 4442, Frame 0759;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, Agent has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including the following:

(a) Each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(b) All products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such trademark, or (b) injury to the goodwill associated with each such Trademark.

2. Agent hereby releases, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent’s right, title and interest (if any) in and to the Trademark Collateral.
