RELEASE OF TRADEMARK SECURITY INTEREST (ABL)

This RELEASE OF TRADEMARK SECURITY INTEREST (ABL) dated as of December 12, 2014 (this "Release"), is made by BMO HARRIS BANK N.A., as collateral agent (the "Collateral Agent"), in favor of DS SERVICES OF AMERICA, INC. (formerly known as DS WATERS OF AMERICA, INC.), a Delaware corporation (the "Pledgor"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Collateral Agreement (as defined below).

WHEREAS, the Pledgor is party to that certain Collateral Agreement (ABL) dated as of August 30, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Pledgor, each subsidiary of the Pledgor identified therein and the Collateral Agent;

WHEREAS, pursuant to that certain Notice of Security Interests (ABL) in Trademarks, dated as of August 30, 2013 (the "Trademark Security Agreement"), made by the Pledgor in favor of the Collateral Agent, the Pledgor pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest (referred to in this Release as the "Security Interest") in all right, title and interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by the Pledgor or in which the Pledgor then had or at any time in the future may acquire any right, title or interest (collectively, but excluding any Excluded Property, the "IP Collateral"):

(a) all trademarks, service marks, corporate names, company names, business names, trade dress, logos and taglines, all registrations thereof (if any), and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office (except for "intent-to-use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. §1051, for which an amendment to allege use or a statement of use has not been filed under Sections 1(c) and 1(d) of Lanham Act, respectively, or, if filed, has not been deemed in conformance with Section 1(a) of the Lanham Act or examined and accepted by the United States Patent and Trademark Office), and all renewals thereof, including those listed on Schedule I hereto and (b) all goodwill associated therewith or symbolized thereby.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 5, 2013 in Reel 5105, Frame 0405; and

WHEREAS, the Secured Obligations have been paid and performed in full and the Collateral Agent has agreed to terminate and release all of its and the Secured Parties' right, title and interest in or to all such IP Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Collateral Agent, on behalf of itself and the Secured Parties, hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges its and the Secured Parties' Security Interest and all of its and the Secured Parties' right, title and interest in or to the IP Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Collateral Agreement or the Trademark Security Agreement, (ii) terminates the Trademark Security Agreement and any other agreement or document delivered in connection with the Trademark Security Agreement and (iii) reassigns to the Pledgor any and all right, title and interest (if any) that the Collateral Agent or any of the Secured Parties may have in or to any of the IP Collateral (including any goodwill associated therewith), together with all rights to sue or to recover, at law or in equity, for any past, present or future infringement, dilution, misappropriation or other violation of the IP Collateral and all rights to any income, royalties, and proceeds arising from or with respect thereto.

2. Authorization to Record. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

3. Further Assurances. The Collateral Agent agrees to cooperate with the Pledgor and to provide the Pledgor with such information and additional authorization and to execute and deliver to Pledgor such additional instruments and to take such action, in each case, as the Pledgor may reasonably request or as may be desirable to effect and record the release of the Collateral Agent's Security Interest in or to the IP Collateral.

4. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.






