**AFFIDAVIT OF RELEASE OF SECURITY AGREEMENT IN TRADEMARKS**

THIS AFFIDAVIT OF RELEASE OF SECURITY INTEREST IN TRADEMARKS, pertains to that certain Trademark Security Agreement (defined below) by Jos A. Bank Clothiers, Inc., a Delaware corporation, and The Joseph A. Bank Mfg. Co., Inc., a New Jersey corporation (as predecessor to The Joseph A. Bank Mfg. Co., Inc., a Delaware corporation) (together, the "Obligors"), in favor of Wells Fargo Bank National Association (the "Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement, dated as of December 31, 1986 and amended as of April 1, 1987 (the "Credit Agreement"), the Obligors granted to the Agent security interests in certain collateral, including the trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith ( the "Trademark Collateral");

WHEREAS, in connection with the Credit Agreement, the Obligors executed that certain Trademark Security Agreement, dated as of April 1, 1987 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), under which the Obligors mortgaged, pledged and granted to the Agent a lien on, and security interest in and to, all of Obligors' right, title and interest in, to and under the Trademark Collateral (together with the security interests granted pursuant to the Credit Agreement, the "Security Interests"), for recording with the United States Patent and Trademark Office and any other appropriate governmental authorities;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 18, 1987 at Reel 0562/Frame 0488; and

WHEREAS, the Obligors have satisfied and fulfilled all of their obligations to release the Agent's Security Interests in the Trademark Collateral.


NOW, THEREFORE, Laura Ann Smith, being duly sworn, and under penalty of perjury, hereby deposes and says as follows:

1. I am Vice President and Assistant Secretary of each of Jos A. Bank Clothiers, Inc. and The Joseph A. Bank Mfg. Co., Inc.

The Obligors have satisfied and fulfilled all of their obligations under the Trademark Security Agreement, and the Security Interests in the Trademark Collateral are no longer in effect and thus have been released. Any right, title or interest of the Agent in the Trademark Collateral have ceased and become void.

All statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true; and further that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the application or document or any registration resulting therefrom.
