RELEASE OF SECURITY INTERESTS IN TRADEMARKS



WHEREAS, Lender now desires to release its security interests in the Trademarks.

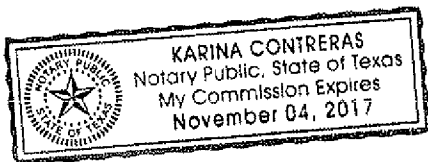
