NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), effective as of December 23, 2014 is made by JPMorgan Chase Bank, N.A., (referred to herein as the "Lender"), in favor of The Chef'n Corporation, a Washington corporation (the "Company"), pursuant to that certain Second Amended and Restated Credit Agreement (and as amended or modified from time to time, the "Credit Agreement") among the Company, Chef'n Acquisition, Inc., and the Lender, dated as of November 16, 2011.

W I T N E S S E T H:

WHEREAS, in connection with the Credit Agreement, the Company have executed and delivered in favor of the Lender the Patent and Trademark Security Agreement, dated as of November 16, 2011 and recorded with the United States Patent and Trademark Office (the "USPTO") on November 16, 2011, at Reel 04805, Frame 0289 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Company pledged and granted to the Lender for the benefit of the Lender a continuing security interest in all of their intellectual property, including but not limited to the trademark applications and registrations set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, in connection with the repayment in full and termination of the Credit Agreement, the Lender has agreed to release any and all right, title and interest it may have in the Release Trademarks pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit and Security Agreement, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreement).

SECTION 2. Release of Security Interest. The Lender does hereby release, relinquish, terminate in its entirety and discharge its continuing security interest in all of the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 3. Further Assurances. The Lender agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or their agents or designees) reasonably request (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 4. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of Washington, but giving effect to federal laws applicable to national banks.

SECTION 5. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
