This TRADEMARK SUPPLEMENT, dated as of January 20, 2015, is delivered pursuant to and supplements (i) the Security Agreement, dated as of September 26, 2014 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time being the "Security Agreement"), among PWC Holding Corporation, a Delaware corporation ("Holdings"), Pacific World Corporation, a California corporation (the "Borrower"), the other Debtors party thereto from time to time, and Prospect Capital Corporation, as Administrative Agent, and (ii) the Trademark Security Agreement dated as of September 26, 2014 (the "IP Security Agreement") by and between Borrower and Administrative Agent. Borrower grants to the Administrative Agent a security interest in all of Borrower's right, title and interest in and to the trademark set forth on Schedule A annexed hereto. Such trademark shall be deemed to be part of the Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the IP Security Agreement.
