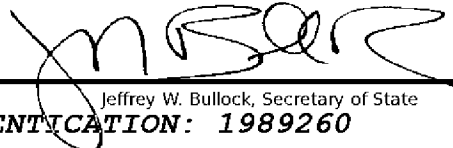

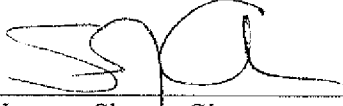
EIGHTH: The Surviving Entity, as a domestic limited liability company of the State of Delaware, agrees that it may continue to be served with process in the State of Delaware.
