INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of January 16, 2015 by and between HERITAGE BANK OF COMMERCE, a California corporation (“**Bank**”) and CONTECH HOLDINGS, LLC, a Florida limited liability company (“**Holdings**”), and CONTECH, LLC (“**Borrower**”) (Holdings and Borrower, collectively, “**Grantor**”).

RECITALS

A. Bank has agreed to make certain advances of money and to extend certain financial accommodations to Borrower in the amounts and manner set forth in that certain Loan and Security Agreement by and between Bank and Borrower (as may be amended from time to time, the “**Loan Agreement**”) dated as of even date herewith. Capitalized terms used herein have the meaning assigned in the Loan Agreement.

B. Holdings entered into that certain Unconditional Guaranty for the benefit of Bank dated as of even date herewith to guaranty Borrower’s obligations under the Loan Agreement (the “**Guaranty**”).

C. Bank is willing to make the financial accommodations to Borrower, but only upon the condition, among others, that Grantor grants to Bank a security interest in all of Grantor’s right title, and interest in, to and under all of the Collateral whether presently existing or hereafter acquired

NOW, THEREFORE, Grantor agrees as follows:

AGREEMENT

1. To secure performance of Borrower’s obligations under the Loan Agreement and Holding’s obligations under the Guaranty, Grantor grants to Bank a security interest in all of Grantor’s right, title and interest in Grantor’s intellectual property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits). This security interest is granted in conjunction with the security interest granted to Bank under the Loan Agreement. Each right, power and remedy of Bank provided for herein or in the Loan Agreement shall not preclude the simultaneous or later exercise by Bank of any or all other rights, powers or remedies.

2. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.
