RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of December 2nd, 2014 by JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, (the "Collateral Agent") to TENNANT COMPANY, (the "Grantor"), as follows:

WHEREAS, on March 4, 2009, the Grantor, certain other Subsidiaries of the Grantor and the Collateral Agent entered into a Pledge and Security Agreement ("Security Agreement") and the Grantor and the Collateral Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (collectively the "Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Collateral Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on March 17, 2009 at recl/frame 3953/757; and

WHEREAS, Collateral Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Collateral Agent hereby releases its security interest in and lien upon the Marks, and reassigns any and all interest it may have in the Marks to the Grantor.
