The Lender hereby releases its liens and security interests and resigns any and all right, title, and interest it may have in and to the following property:



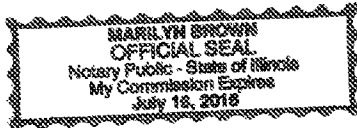
