TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of June 9, 2014 ("Release"), is made by **BANK OF AMERICA, N.A.**, as Collateral Agent ("Collateral Agent"), in favor of **ARBITRON INC.**, a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of March 29, 2001 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Collateral Agent, and the other parties from time to time party thereto and the Supplemental IP Security Agreement dated as September 30, 2005 ("IP Security Agreement") by and among the Grantor and Collateral Agent, Grantor granted to the Collateral Agent, for the benefit of the Credit Agents, a security interest in all of Grantor's right, title and interest in, to and under the Collateral, including the Intellectual Property ("Security Interest");

WHEREAS, the IP Security Agreement was recorded at the Trademark Division of the United States Patent and Trademark Office ("USPTO") on November 1, 2005 at Reel 3245 Frame 0329 and at the United States Copyright Office ("USCO") on November 1, 2005 at Volume 3530 Doc. No. 903; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Intellectual Property.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Credit Agents, and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or IP Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Credit Agents, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Security Interest in the Intellectual Property, including, but not limited to, the foregoing listed on Schedule 1 attached hereto, and any right, title, or interest of the Collateral Agent therein shall hereby cease and become void; and


(b) authorizes the recordation of this Release with the USPTO and USCO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Credit Agents, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
