**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS
(UNITED STATES)**

TERMINATION AND RELEASE dated as of February 6, 2015 from THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., as Notes Collateral Agent (in such capacity, the "Agent") for the Secured Parties, to AMERICAN TIRE DISTRIBUTORS, INC. ("Company"), a Delaware corporation, with offices at 12200 Herbert Wayne Court, Suite 150, Huntersville, North Carolina 28078, and AM-PAC TIRE DIST. INC. ("Am-Pac"), a California corporation with offices at 12200 Herbert Wayne Court, Suite 150, Huntersville, North Carolina 28078, (Company and Am-Pac, collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of May 28, 2010, made by the Grantors in favor of the Agent, a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of May 28, 2010, among the Grantors and the Agent (the "Trademark Security Interest"), the Grantors, by reference to the Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent for the benefit of the Secured Parties (as defined in the Security Agreement) specifically in certain Trademark Collateral; and

WHEREAS, the Trademark Security Interest was recorded in the United States Patent & Trademark Office on June 24, 2010, at Reel 004231, Frame 0440; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Trademark Collateral: The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest in, to and under as of the date hereof the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Trademark Security Interest.

2. Release of Security Interest: The Agent, hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by the Grantors to effect the release of the Security Interest contemplated hereby.

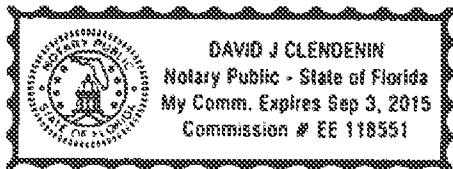
