**RELEASE OF TRADEMARK ASSIGNMENT AND SECURITY AGREEMENT**  
(AWP Windows and Doors, LLC)

WHEREAS, AWP Windows and Doors, LLC, a Delaware limited liability company whose address is 276 East Deerpath Road, #402, Lake Forest, IL 60045 (the "Grantor"), entered into that certain Trademark Assignment and Security Agreement effective as of March 20, 2014 (the "Security Agreement"), between the Grantor and ACF FINCO I LP, a Delaware limited partnership and successor to Keltic Financial Partners II, LP, with a place of business at 580 White Plains Road, Suite 610, Tarrytown, New York 10591 (in such capacity, the "Secured Party"), under the Loan and Security Agreement (the "Loan Agreement") dated effective March 20, 2014, by and between Secured Party and Grantor, a true and correct copy of said Security Agreement having been recorded with the United States Patent and Trademark Office on March 24, 2014, at Reel 5262, Frame 0505; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement, without recourse or representation or warranty, express or implied;
2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given;
3. Represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; and
4. Shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
