**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made this 25 day of June, 2012, by Brocko Inc., a Texas corporation as agent for certain secured parties (in such capacity, "Agent").

WHEREAS, reference is made to that Trademark Collateral Security Agreement dated April 8, 1999 (as amended, restated, amended and restated, supplemented and/or modified to date, the "Trademark Collateral Security Agreement"), by and among FWT, Inc., a Texas corporation (the "Company") and Agent. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Trademark Security Agreement.

WHEREAS, the Trademark Collateral Security Agreement was recorded with the United States Patent and Trademark Office on April 19, 1999, at Reel 001887, Frame 0059.

WHEREAS, reference is made to that Restated Trademark Collateral Security Agreement dated December 31, 1999 (as amended, restated, amended and restated, supplemented and/or modified to date, the "Restated Trademark Collateral Security Agreement"), by and among the Company and Agent. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Restated Trademark Collateral Security Agreement.

WHEREAS, the Restated Trademark Collateral Security Agreement was recorded with the United States Patent and Trademark Office on January 24, 2000, at Reel 002021, Frame 0638.

WHEREAS, under the Trademark Collateral Security Agreement and the Restated Trademark Collateral Security Agreement, the Company granted to Agent, for the benefit of itself and the Secured Parties, a continuing security interest in all of the right, title and interest of the Company in and to the trademark collateral identified therein (collectively, the "Trademark Collateral").

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby irrevocably releases and terminates all its security interest in and to the Trademark Collateral, including without limitation, the trademarks described in the schedules attached to the Trademark Collateral Security Agreement and the Restated Trademark Collateral Security Agreement, and attached as Schedule I hereto.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
