PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARKS

THIS PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARKS (this "Termination"), is dated as of February 27, 2015, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement, having an office at 500 First Avenue, Commercial Loan Service Center/DCC, Pittsburgh, Pennsylvania 15219 ("Grantee") to **MERVIN MANUFACTURING, INC.**, a California corporation ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 10, 2014, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by Grantor to Grantee in certain collateral, including the Specified Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 29, 2014, at Reel 5390 and Frame 0372; and

WHEREAS, Grantee now desires to terminate and release its security interest in the Specified Trademark Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Specified Trademark Collateral," as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates, releases and discharges its security interest in the Specified Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Specified Trademark Collateral.
