TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 27, 2015, by PNC Bank, National Association, as agent ("Grantee").

WITNESSETH:

WHEREAS, Grantee and Crossbridge Solutions, Inc. ("Grantor") entered into that certain Grant of Security Interest in United States Trademarks dated as of June 26, 2014 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in, among other things, all of Grantor's Marks, including all of Grantor's right, title and interest in and to the United States trademark number 3636754 registered on June 9, 2009; and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark office on June 26, 2014 at Reel 5309, Frame 0852; and

WHEREAS, Grantee no longer has an interest in the Marks described in the Security Agreement; and

WHEREAS, Grantor has requested that Grantee release its lien on the Marks, including the United States trademark number 3636754 registered on June 9, 2009, and reassign the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases any and all claims, liens, and other encumbrances arising under the Security Agreement and reassigns any and all rights, titles and interests in the Marks conveyed thereunder, without any representation, recourse or undertaking by Grantee, to Grantor.
