TRADEMARK RELEASE

This TRADEMARK RELEASE, granted on this ____ day of March, 2015, by Deutsche Bank Trust Company Americas, as Collateral Agent, with principal offices at 60 Wall Street, New York, New York 10005 (the "Grantee"), to Sunrise Medical HHG Inc., a California corporation, with principal offices at 7477 East Dry Creek Parkway, Longmont, CO 80503 (the "Grantor"), as follows:

WITNESSETH

WHEREAS, the Grantor has heretofore assigned and granted to the Grantee a security interest in certain U.S. trademarks, trademark registrations as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations as defined in a certain Grant of Security Interest in United States Trademarks, entered into by and between Grantee and Grantor on May 13, 2004 and recorded at recorded in the United States Patent and Trademark Office at Reel 3990, Frame 0298 (the "Security Agreement"); and

WHEREAS, the Grantee wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all liens and encumbrances respecting the Marks (and only those Marks) shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Marks, and more particularly, the security interest in (i) the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses symbolized by the Marks and (iv) all causes of action arising prior to or after the date of the earliest assignment and grant hereunder for infringement of any of the Marks or unfair competition regarding the same, and granted to the Grantee by the Grantor by the Security Agreement.


