RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this “Release”) is made as of March 20, 2015 (“Effective Date”) by Wells Fargo Bank, National Association (“Wells Fargo”) in favor of Superwinch, LLC (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor, Wells Fargo and the other parties thereto entered into that certain Credit and Security Agreement dated October 15, 2009 (the “Security Agreement”) which required the parties to enter into the IP Security Agreement (defined below);

WHEREAS, Grantor, Wells Fargo and the other parties thereto entered into that certain Patent and Trademark Security Agreement dated October 15, 2009 (the “IP Security Agreement”), to record the security interest granted by Grantor in favor of Wells Fargo in (a) all of Grantor’s right, title and interest in and to patents or applications for patents, fees or royalties with respect to each, and including without limitation the right to sue for past infringement and damages therefor, and licenses thereunder, all as then existing or thereafter arising or acquired, and (b) all of Grantor’s right, title and interest in and to (i) trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective goodwill associated with each, (ii) licenses, fees or royalties with respect to each, (iii) the right to sue for past, present and future infringement, dilution and damages therefor, and (iv) licenses thereunder, all as then existing or thereafter arising or acquired, including, without limitation, the marks listed on Exhibit A (the items contained in (a) and (b) collectively, the “IP Collateral”), and such IP Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2009, at Reel 4101, Frame 0409;

WHEREAS, Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the IP Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo hereby terminates the IP Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to or under the IP Collateral, together with the goodwill of the business symbolized thereby.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
