## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of March 14, 2014 (the “**Release**”), is made by BMO HARRIS BANK, N.A., in its capacity as Agent (together with its successors and assigns, the “**Agent**”), in connection with the termination of that certain Intellectual Property Security Agreement, dated as of June 29, 2012 (“**I.P. Security Agreement**”), made by SHOCK DOCTOR, INC. (the “**Grantor**”), in favor of the Agent.

### WITNESSETH

WHEREAS, pursuant to the I.P. Security Agreement, the Grantor granted the Agent a security interest in (i) all patents and patent applications listed on Schedule 1 hereto, (ii) all reissues, divisions, continuations, renewals, extensions, continuations-in-part thereof, (iii) all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including but not limited to under any licenses and any damages for past, present or future infringement thereof, (iv) the right to sue for past, present or future infringements thereof, and (v) all rights corresponding thereto throughout the world (collectively, the “**Patent Collateral**”);

WHEREAS, with respect the Patent Collateral, the I.P. Security Agreement was recorded with the U.S. Patent and Trademark Office (the “**USPTO**”) on July 25, 2012 at Reel 028633, Frame 0744;

WHEREAS, pursuant to the I.P. Security Agreement, the Grantor granted the Agent a security interest in (i) all registered trade names, trademarks, service marks and applications therefore listed on Schedule 2 hereto, (ii) any renewals thereof, (iii) all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including but not limited to under any licenses and any damages for past, present or future infringement thereof, (iv) the right to sue for past, present or future infringements thereof, (v) all rights corresponding thereto throughout the world, (vi) all goodwill of Borrower's business connected with and symbolized by the foregoing, and (vii) license agreements with any other party in connection with any Trademarks or such other party's trademarks, registered trademarks and trademark applications, trade names, service marks, registered service marks and service mark applications, whether Grantor is a licensor or licensee under such license agreement, including but not limited to, the material license agreements listed on Schedule 3 hereto (collectively, the “**Trademark Collateral**”);

WHEREAS, with respect to the Trademark Collateral, the I.P. Security Agreement was recorded with the USPTO on July 25, 2012 at Reel 4828, Frame 0691;

WHEREAS, pursuant to the I.P. Security Agreement, the Grantor granted the Agent a security interest in (i) all registered copyrights listed on Schedule 4 hereto, (ii) any renewals thereof, (iii) all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including but not limited to under any licenses and any damages for past, present or future infringement thereof, (iv) the right to sue for past, present or future infringements thereof, and (v) all rights corresponding thereto throughout the world (collectively, the “**Copyright Collateral**” and, together with the Patent Collateral and the Trademark

Collateral, the “**I.P. Collateral**”)

WHEREAS, the Agent acknowledges full payment, complete performance and satisfaction of all obligations secured by the I.P. Security Agreement;

WHEREAS, the Grantor has requested that the Agent release its security interest in the I.P. Collateral, and all other intellectual property of the Grantor, in connection with the termination of the I.P. Security Agreement (the “**Released Collateral**”).

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby releases and terminates, without representation, warranty or recourse, all of its security interest in the Released Collateral.

The Agent agrees to, at their request, provide the Grantor with any information and additional authorization reasonably necessary to effect the release of its security interest in the Released Collateral, in each case, without representation or warranty by the Agent and at the sole expense of the Grantor.
