**RELEASE OF SECURITY INTEREST  
IN CERTAIN TRADEMARKS AND TRADEMARK APPLICATIONS**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made effective as of April 30, 2015 by The Bank of New York Mellon Trust Company, N.A., as collateral agent (the “Collateral Agent”) to ALLEN SYSTEMS GROUP, INC. (the “Grantor”), as follows:

**WITNESSETH:**

**WHEREAS**, the Grantor holds all right, title and interest in and to the trademarks and trademark applications listed on the annexed Schedule I, which trademarks are registered in and trademark applications are filed in the United States Patent and Trademark Office (the “Trademarks”);

**WHEREAS**, (i) on November 22, 2010, the Grantor entered into a Trademark Security Agreement (the “November 2010 Agreement”) and (ii) on May 31, 2012, the Grantor entered into a Second Lien Trademark Security Agreement (the “May 2012 Agreement” and together with the November 2010 Agreement, the “Agreements”), pursuant to which the Grantor granted to Collateral Agent for its benefit and for the ratable benefit of each other Secured Party (as defined in each of the Agreements) a continuing security interest in the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof to secure the payment, performance and observance of certain obligations;

**WHEREAS**, (i) the November 2010 Agreement was recorded in the United States Patent & Trademark Office on November 30, 2010, at Reel/Frame 004409/0743 and a Corrective Assignment was recorded on February 18, 2011, at Reel/Frame 004481/0103 and (ii) the May 2012 Agreement was recorded in the United States Patent & Trademark Office on July 9, 2012 at Reel/Frame 004817/0167; and

**WHEREAS**, pursuant to (i) Section 4.11 of the Debtors’ First Amended Joint Prepackaged Chapter 11 Plan (with Technical Modifications) dated March 27, 2015 [Docket No. 183-1], (the “Plan”) which was filed in the United States Bankruptcy Court in the District of Delaware in a case captioned, In re Allen Systems Group, Inc. et al. (Case No. 15-10332 (KJC)), and (ii) paragraph 79 of the Findings of Fact, Conclusions of Law, and Order Approving the Debtors’ Disclosure Statement for, and Confirming, the Debtors’ First Amended Joint Prepackaged Chapter 11 Plan (with Technical Modifications) dated March 27, 2015 [Docket No. 183] (the “Confirmation Order”), except as otherwise provided in the Plan or Confirmation Order, all notes, instruments, certificates and other documents evidencing Claims or Interests (as those terms are defined in the Plan) shall be canceled);

**NOW, THEREFORE**, the Collateral Agent hereby releases and discharges its security interest in the Trademarks, including the trademark registrations and applications identified in Schedule I.
