**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of April 30, 2015, from JPMorgan Chase Bank, N.A., as Agent (in such capacity, the "Agent") for the Lenders, to Exide Technologies, a Delaware corporation, a debtor and a debtor-in-possession in a case under Chapter 11 of the Bankruptcy Code (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the US Security Agreement, dated as of June 13, 2013, made by the Grantor (as defined therein) in favor of JPMorgan Chase Bank, N.A., as the Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 13, 2013 between the Agent and Grantor (the "Trademark Security Agreement"), Grantor affirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on June 14, 2013 at Reel 5046, Frame 0432; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest in and to the following:

(a) any and all of Grantor's trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks, service mark applications, logos and other source or business identifiers, including:

(i) the trade names, registered trademarks, trademark applications, registered service marks and service mark applications listed on Schedule A hereto;

(ii) all renewals thereof;

(iii) all income, royalties, damages and payments now and hereafter due or payable under and with respect thereto, including payments under all

licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof;

(iv) the right to sue for past, present and future infringements, misappropriations, violations, and dilutions thereof;

(v) the goodwill of Grantor's business symbolized by the foregoing or connected therewith; and

(vi) all of Grantor's rights corresponding thereto throughout the world; and

(b) all Proceeds of each of the foregoing, as defined in the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, cancels, releases and discharges its Security Interest in and lien upon the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby terminate, cease and become void.

3. Authorization to Record. The Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

4. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

5. Governing Law. This Release is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to conflicts of laws principles.
