## **NOTICE OF RELEASE OF SECURITY INTEREST**

This Notice of Release of Security Interest (the “Release”) is effective as of May 6, 2015, by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors, “Secured Party”).

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement and the Credit Agreement (as defined in the Security Agreement), Secured Party hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to the Intellectual Property, including, without limitation, the trademarks set forth on Exhibit A attached hereto, and hereby authorizes the Grantor or Grantor’s authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor’s counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.
