RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

May 15, 2015

WHEREAS, STERIGENICS U.S., LLC, a Delaware limited liability company ("*Sterigenics*") granted a security interest (the "*Security Interest*") in and a lien upon the Trademarks (as defined below) to U.S. BANK NATIONAL ASSOCIATION, as collateral agent ("*Secured Party*"), as set forth in that certain Grant of Security Interest in Trademark Rights dated as of March 25, 2011, including any supplements prior to the date hereof (the "*Trademark Security Agreement*"), by Sterigenics in favor of Secured Party, which was recorded in the United States Patent and Trademark Office on March 25, 2011 at Reel 004506, Frame 0248; and

WHEREAS, the indebtedness secured by the Security Interest has been paid in full, and Sterigenics has requested that Secured Party release to Sterigenics any and all of its right, title and interest in, to and under all Intellectual Property, including the Trademarks (as such terms are defined in that certain Security Agreement dated as of March 25, 2011 by certain Sterigenics affiliates in favor of Secured Party, including any supplements prior to the date hereof (the "*Security Agreement*")), including, without limitation, those items identified in Schedule I annexed hereto and made a part hereof.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. absolutely, unconditionally and irrevocably terminates, cancels and releases to Sterigenics any and all liens, security interests, right, title and interest that Secured Party or its predecessors, successors and assigns may have pursuant to the Trademark Security Agreement in or to the Trademarks (as defined in the Security Agreement), including, without limitation, those items identified in Schedule I and/or any goodwill associated with any of the Trademarks (as defined in the Security Agreement) identified in Schedule I, without representation or warranty, express or implied, of any kind, except as set forth in Section 4 herein;

2. agrees that any power of attorney or similar rights granted by Sterigenics to Secured Party or its predecessors, successors and assigns with respect to the Trademarks (as defined in the Security Agreement), including, without limitation, those items identified in Schedule I, pursuant to or in connection with the Trademark Security Agreement is terminated;

3. agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this release;

4. represents and warrants that it has full authority to execute and deliver this release;  
and

5. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

Governing Law. THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY AND SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.

This release shall be binding upon Secured Party's representatives, successors, assigns and transferees and is made in favor of and for the benefit of Sterigenics and its successors and assigns.
