RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of May 7, 2015 (this "**Release**"), by CREDIT SUISSE AG, as Collateral Agent (in such capacity, the "**Collateral Agent**") in favor of DJO, LLC, a Delaware limited liability company, ENCORE MEDICAL ASSET CORPORATION, a Nevada corporation, ELASTIC THERAPY, LLC, a North Carolina limited liability company, and RIKCO INTERNATIONAL, LLC, a Wisconsin limited liability company (each a "**Grantor**" and together the "**Grantors**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of November 20, 2007, as amended and restated as of March 20, 2012 (as further amended, amended, supplemented or modified from time to time, the "**Credit Agreement**"), among DJO Finance LLC (f/k/a ReAble Therapeutics Finance LLC), a Delaware limited liability company (the "**Borrower**"), DJO Holdings LLC (f/k/a ReAble Therapeutics Holdings LLC), a Delaware limited liability company ("**Holdings**"), Credit Suisse AG, as Administrative Agent, Collateral Agent, Swing Line Lender and L/C Issuer, and each lender party thereto, (ii) the Intellectual Property Security Agreement dated as of November 20, 2007 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**") among the Borrower, Holdings, certain Subsidiaries of Holdings identified therein and the Collateral Agent, (iii) the Trademark Security Agreement dated as of November 20, 2007, among the Borrower, Holdings, DJO, LLC and the Collateral Agent, (iv) the Trademark Security Agreement dated as of November 20, 2007, among the Borrower, Holdings, Encore Medical Asset Corporation and the Collateral Agent, (v) the Trademark Security Agreement dated as of April 22, 2009, among the Borrower, Holdings, Encore Medical Asset Corporation and the Collateral Agent, (vi) the Trademark Security Agreement dated as of April 22, 2009, among the Borrower, Holdings, Encore Medical Asset Corporation and the Collateral Agent, (vii) the Trademark Security Agreement dated as of May 11, 2010, among the Borrower, Holdings, DJO, LLC and the Collateral Agent, (viii) the Trademark Security Agreement dated as of February 1, 2011, among the Borrower, Holdings, Encore Medical Asset Corporation and the Collateral Agent, (ix) the Intellectual Property Security Agreement Supplement of Elastic Therapy, LLC dated as of March 17, 2011, among Elastic Therapy, LLC and the Collateral Agent, (x) the Intellectual Property Security Agreement Supplement of Rikco International, LLC dated as of April 7, 2011, among Rikco International, LLC and the Collateral Agent, and (xi) the Trademark Security Agreement dated as of November 10, 2011, among the Borrower, Holdings, DJO, LLC and the Collateral Agent (the documents set forth in clauses (iii) through (xi), the "**Trademark Security Agreements**").

B. Pursuant to the Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of each Grantor in, among other property, the Trademarks set forth on

Schedule I hereto (the “*Trademark Collateral*”), and pursuant to the Trademark Security Agreements, such security interest was recorded with the United States Patent & Trademark Office on (i) December 13, 2007 at Reel/Frame 3677/0361, (ii) December 13, 2007 at Reel/Frame 3677/0338, (iii) May 5, 2009 at Reel/Frame 3982/0491, (iv) March 2, 2010 at Reel/Frame 4159/0253, (v) June 2, 2010 at Reel/Frame 4216/0772, (vi) April 21, 2011 at Reel/Frame 4526/0477, (vii) May 18, 2011 at Reel/Frame 4544/0145, (viii) May 18, 2011 at Reel/Frame 4544/0053, and (ix) November 21, 2011 at Reel/Frame 4663/0847.

C. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests in connection therewith, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, does hereby terminate, release, relinquish and discharge its security interest in the Trademark Collateral. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.

AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
