RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of May 29, 2015 by Citizens Bank of Pennsylvania, acting in its capacity as Administrative Agent for certain lenders (in such capacity, the “**Agent**”), in favor of 3D RESEARCH CORPORATION (“3D”), SCHAFER CORPORATION (n/k/a Schafer Government Services, LLC) (“Schafer”), and ASYNCHRONY SOLUTIONS, INC. (“**Asynchrony**”, and collectively, with 3D and Schafer, the “**Grantors**”).

WHEREAS, 3D and Schafer (the “**Copyright Grantors**”) granted a security interest in certain copyrights to the Agent, as set forth in that certain Grant of Security Interest in Copyrights, dated as of June 16, 2011 by the Copyright Grantors in favor of the Agent, which was recorded with the Copyright Office on July 18, 2011 as Document no. V3606D063 (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the “**Copyright Grant**”);

WHEREAS, 3D and Asynchrony (the “**Trademark Grantors**”) granted a security interest in certain trademarks to the Agent, as set forth in that certain Grant of Security Interest in Trademarks, dated as of June 16, 2011 by the Trademark Grantors in favor of the Agent, which was recorded with the USPTO on July 11, 2011, at Reel 004579 and Frame 0689 (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the “**Trademark Grant**”);

WHEREAS, the Agent desires to release the security interest held by the Agent in those certain copyrights identified in Exhibit A attached hereto;

WHEREAS, the Agent desires to release the security interest held by the Agent in those certain trademarks identified in Exhibit B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby: (i) terminates the Copyright Grant and releases and discharges the Agent’s security interest in the copyrights identified on Exhibit A; and (ii) terminates the Trademark Grant and releases and discharges the Agent’s security interests in and continuing lien on the trademarks identified in Exhibit B, including all goodwill and other rights associated with such trademarks in which the Agent was granted a security interest pursuant to the Trademark Grant, without any representation, warranty or recourse of any kind.

2. The Agent hereby authorizes and requests that the United States Patent and Trademark Office and the Copyright Office note and record the existence of the releases hereby given.
