RELEASE OF SECURITY INTEREST

This Release of Security Interest is made effective as of October 1, 2013 (this "Release"), by Gold Hill Capital 2008, LP ("Lender") in favor of SENDMAIL, INC., a Delaware corporation ("Company") with its principal place of business located at 6475 Christie Avenue, Suite 350, Emeryville, CA 94608.

RECITAL

WHEREAS Company and Lender entered into a Loan and Security Agreement dated as of January 31, 2013 as may have been amended, modified, or otherwise supplemented from time to time (the "Loan Agreement").

WHEREAS, in connection with the Loan Agreement, Company granted to Lender a security interest in the patents and trademarks set forth on Exhibits A and B, respectively, attached hereto (collectively, the "Intellectual Property") under an Intellectual Property Security Agreement dated as of January 31, 2013 (the "Security Agreement") and recorded with the U.S. Patent and Trademark Office in the patent assignments branch at Reel/Frame 029745/0107 and in the trademark assignments branch at Reel/Frame 4955/0001.

WHEREAS, pursuant to that certain Payoff Agreement dated as of October 1, 2013 by and between Lender and Company, Company has no outstanding obligations to Lender under the Loan Agreement or under the Security Agreement, and therefore Lender agrees to release its security interest in the Intellectual Property.

AGREEMENT

Now therefore, Lender agrees that it terminates and releases its security interest in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.
