TRADEMARK ASSIGNMENT

Assignor authorizes the United States Patent and Trademark Office, the Canada Intellectual Property Office, the Instituto Mexicano de la Propiedad Industrial and any other applicable jurisdictions outside the United States to record the transfer of the registrations and/or registration applications set forth in Exhibit "A" to Assignee as recipient of Assignor's entire right, title and interest therein.

Assignor further agrees, at the request and expense of Assignee, to cooperate with Assignee in the protection of the Trademark rights and prosecution and protection thereof and to execute and deliver any papers and perform other acts to maintain the registrations and to implement the intent of this Assignment as Assignee may lawfully request.

2. Assignor represents and warrants that it owns the entire right, title and interest in the Trademarks by mesne assignments or otherwise, that there are no liens or security interests against the Trademarks; and that Assignor has all authority necessary to enter into this Agreement and the execution and delivery of this Agreement has been duly and validly authorized.
3. This Assignment shall be binding on and shall inure to the benefit of the parties to this Assignment and their successors and assigns, if any.
4. This Assignment, together with Exhibit "A" hereto, constitute the entire agreement of the parties with respect to the subject matter hereof. No modification of or additions to this Assignment shall be effective unless in writing and properly executed by both parties.
