RELEASE AND REASSIGNMENT OF SECURITY INTEREST

IN

TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS is made as of June 12, 2015, by NexBank, SSB, in its capacity as Agent (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Loan and Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Term Loan and Security Agreement dated as of June 12, 2014 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Loan and Security Agreement”) by and among the Loan Parties party thereto (each an “Obligor” and collectively, the “Obligors”) and NexBank, SSB, as administrative agent (in such capacity, together with its successors and assigns in such capacity, the “Agent”) for itself and the lenders referenced therein (the “Lenders”), the Obligors granted a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule 1 attached hereto (collectively, the “Trademarks”) to the Agent for the ratable benefit of itself and the Lenders.

WHEREAS, the Loan and Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 13, 2014, at Reel 5302, Frame 0001; and

WHEREAS, Obligor has requested that Secured Party release its security interest in the Trademarks and reassign any and all rights in the same to Obligor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Obligor’s right, title and interest in and to the Trademarks.
2. Secured Party hereby reassigns, grants and conveys to the Obligor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party’s right, title and interest in and to the Trademarks.
