RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of May 29, 2015 ("Effective Date") by U.S. BANK NATIONAL ASSOCIATION, as Collateral Agent (in such capacity, the "Collateral Agent") in favor of HORIZON LINES, LLC (the "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor and the Collateral Agent entered into that certain Security and Pledge Agreement by and between Grantor and the Collateral Agent (for the benefit of the Secured Parties), dated January 31, 2013 (the "Security Agreement"), related to the \$20,000,000 Term Loan, wherein Grantor granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to certain assets of the Grantor;

WHEREAS, pursuant to the Security Agreement, that certain Trademark Security Agreement, dated January 31, 2013 (the "Trademark Security Agreement") was (a) entered into by Grantor and the Collateral Agent to record the security interest with respect to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, those items set forth on Schedule A hereto, and (b) recorded with the United States Patent and Trademark Office on February 4, 2013, at Reel 4955, Frame 0141; and

WHEREAS, Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, including, without limitation, those items set forth on Schedule A hereto, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested, in writing, by Grantor to relinquish and effect the release of such rights to Grantor, at the sole expense of Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Agent's rights under the Security Agreement with respect to the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
