**RELEASE OF LIEN OF TRADEMARKS**

**WHEREAS**, Imedex, LLC (the "Company") owns the Trademarks described in Schedule A attached hereto (the "Named Trademarks");

**WHEREAS**, pursuant to and in connection with that certain Supplement No. 9, dated as of July 26, 2004, to the Security Agreement dated as of August 29, 2001 (as amended, modified or supplemented from time to time, the "Security Agreement") between AmerisourceBergen Corporation ("AmerisourceBergen") and JPMorgan Chase Bank ("JP Morgan"), the Company granted a security interest in the Named Trademarks to JP Morgan as Collateral Agent to secure the payment and performance by AmerisourceBergen of certain of its obligations under the Credit Agreement dated as of August 29, 2001, as amended, among AmerisourceBergen Corporation, as borrower, the lenders party thereto and JPMorgan Chase Bank, N.A., as administrative agent (the "Prior Credit Agreement");

**WHEREAS**, the aforementioned Security Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office, on August 8, 2004 located on Reel 3022, Frame 0687; and

**WHEREAS**, in connection with the execution of a replacement Credit Agreement dated as of December 2, 2004 among AmerisourceBergen Corporation, as borrower, the lenders party thereto and JPMorgan Chase Bank, N.A., as administrative agent, the loans and other amounts outstanding or payable under the Prior Credit Agreement were repaid in full, the Security Agreement was terminated; and it was the intention of the parties that all liens securing such loans and other amounts be released;

**NOW THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, JPMorgan in its capacity as Collateral Agent under the Prior Credit Agreement does hereby terminate and release its lien and security interest in, and reassign and re-convey to the Company all of JPMorgan's right, title and interest in and to, each of the Named Trademarks and related trademark registrations and goodwill, effective as of the date set forth below.
