**RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of June 19, 2015 (this "Release"), is made by General Electric Capital Corporation, as Collateral Agent for the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, the "Collateral Agent"), in favor of Sterling Infosystems, Inc., a Delaware corporation (the "Borrower"), American Background Information Services, Inc., a Virginia corporation, Bishops Services, Inc., a Delaware Corporation, Abso, a California corporation, Sterling Infosystems-Ohio, Inc., an Arkansas corporation, and Screening International LLC, a Delaware limited liability company, each with an office located at 1 State Street Plaza, 24<sup>th</sup> Floor, New York, NY 10004 (each, a "Grantor," and collectively, the "Grantors"). Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and/or the Security Agreement (each as defined below), as applicable.

**WITNESSETH**

WHEREAS, pursuant to that certain Credit Agreement, dated as of May 13, 2014 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Credit Agreement"), by and among the Borrower, Sterling Infosystems Holdings, Inc., the Lenders and Issuers party thereto from time to time, and the Collateral Agent, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantors have executed and delivered that certain Security Agreement, dated as of May 13, 2014, in favor of the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors and the Collateral Agent entered into a Trademark Security Agreement, dated as of May 13, 2014 (the "Trademark Security Agreement"), pursuant to which, as security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in, all of such Grantor's right, title and interest in, to and under all of the following (collectively, the "Trademark Collateral"):

(a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, the goodwill of the business symbolized thereby or associated therewith, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or political subdivision thereof, and all extensions and renewals thereof and any amendments thereto, including those listed on Schedule A attached hereto;

(b) all rights and privileges arising under applicable Law with respect to such Grantor's use of any trademarks;

(c) all extensions and renewals thereof;

(d) all income, fees, royalties, damages and payments then and thereafter due and/or payable with respect to any of the foregoing, including damages, claims, and payments for past, present or future infringements thereof;

(e) all rights corresponding thereto throughout the world;

(f) all rights to sue for past, present and future infringements or dilutions thereof; and

(g) to the extent not otherwise included, all Proceeds and products of any and all of the foregoing and all collateral security and guarantees given by any Person with respect to any of the foregoing;

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on May 19, 2014 at Reel/Frame Nos. 5282/0564, 5282/0582, 5282/0591, 5282/0600, 5282/0620 and 5282/0629; and

WHEREAS, the Grantors have requested that the Collateral Agent release, and the Collateral Agent agrees to hereby release, its security interest in the Trademark Collateral.


NOW, THEREFORE, the Collateral Agent, without any recourse to the Collateral Agent or any Secured Party and without any representation or warranty being made the Collateral Agent or any Secured Party, and at the Grantors' sole cost and expense, hereby terminates, cancels, releases and discharges fully its security interest in each Grantor's Trademark Collateral, including the trademarks and trademark applications listed on Schedule A attached hereto, and any right, title and interest of the Collateral Agent in the Trademark Collateral shall hereby terminate, cease and become void.

THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY AND SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
