**TERMINATION OF SECURITY INTEREST
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of June 30, 2015, is made by PNC Bank, National Association, as administrative agent (the "Agent") (formerly known as National City Bank).

WHEREAS, Firstmark Corp., a Maine Corporation ("Firstmark"), Firstmark Aerospace Corp., a Delaware corporation ("Aerospace"), Aircraft Belts, Inc., a Texas corporation ("Aircraft Belts"), and Twin Commander Aircraft LLC, a Washington limited liability company ("Twin Commander") (Twin Commander, together with Firstmark, Aerospace, and Aircraft Belts are each individually a "Borrower" and collectively the "Borrowers") granted to the Agent a security interest in certain property, including without limitation, a security interest in the Trademark Collateral (as defined below) pursuant to that certain Loan and Security Agreement, dated as of August 28, 2008 (as amended, restated, modified or supplemented from time to time, the "Credit Agreement"), by and among the Borrowers, the lenders party thereto and the Agent;

WHEREAS, an Intellectual Property Security Agreement with respect to the security interest in the Trademark Collateral (as defined below) was recorded with the United States Patent and Trademark Office on August 8, 2008; and

WHEREAS, the Agent has agreed to terminate and release its security interest in all such property, including without limitation, the Trademark Collateral (as defined below) as herein provided.

NOW, THEREFORE, for valuable consideration, the Agent hereby absolutely, unconditionally and irrevocably terminates and releases all liens and security interests granted to the Agent in the following property:

- (i) each trademark, trademark registration, and trademark application

listed on Schedule A annexed hereto (such trademarks and trademark applications, the “Trademarks”), together with any renewals or divisions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all proceeds of the foregoing, including without limitation, any claim by any Borrower against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark ((i) and (ii) collectively, the “Trademark Collateral”).


The Agent represents and warrants that it has full authority to execute and deliver this Release, and agrees to reasonably cooperate with the Borrowers and to execute and deliver any other instrument required to effect the release of the Agent’s security interest in the released collateral described herein.

This Termination of Security Interest and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
