ASSIGNMENT OF MARKS

WITNESSETH:

WHEREAS, Assignor desires to assign to Assignee all of its right, title and interest in and to all trademarks and service marks owned by Assignor, including without limitation the trademarks BOUTIQUE, CURRENTLY OBSESSED, LIKE TO KNOW, LIKE TO KNOW IT, LIKE TO KNOW IT DESIGN, LINK NINJA, ENVELOPE DESIGN, MONEY SPOT, PASSPORT, REWARDSTYLE, REWARDSTYLE DESIGN, RSTYLE, RESTYLE.ME, and STALK, as well as the trademarks and service marks set forth in Exhibit "A" attached hereto (collectively, the "Marks"); and


WHEREAS, Assignee desires to acquire from Assignor the entirety of Assignor's right, title and interest in and to the Marks;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (US \$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment. Assignor does hereby, as of the Effective Date, assign, transfer and sell to Assignee all of Assignor's right, title, and interest in and to the Marks, together with (a) all goodwill of the business associated therewith and symbolized thereby, (b) all of Assignor's rights to sue for past, present or future infringement or other violation and to collect all past, present and future damages related thereto, and (c) all of Assignor's rights corresponding to the foregoing throughout the world. The Parties acknowledge that Assignee is a successor to the business of the Assignor or to the portion of the business to which such Marks apply, which business is ongoing and existing.
2. Further Assurances. At the request of Assignee, its successors and/or assigns, Assignor will, without additional consideration, timely execute all papers and perform such other acts as Assignee, its successors or assigns, deem necessary to ensure that Assignee is the sole owner of the entire right, title, and interest in and to the Marks, and to otherwise give full and proper effect to this Assignment of Marks. Assignor further agrees, without additional consideration, to: (a) cooperate with Assignee in the prosecution of any applications for registration of the Marks; and (b) perform such other acts as Assignee may request to obtain, maintain, protect or enforce the Marks.
3. Counterparts. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original for all purposes but all of which when taken together shall constitute a single counterpart instrument.




