NOTICE OF RELEASE OF SECURITY INTEREST


WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on November 30, 2011 at Reel/Frame 4668/0895;

Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.
