**FORM OF ASSIGNMENT OF TRADEMARKS**

This Assignment of Trademarks (the "Assignment") is being executed by Innovative Brewing, LLC, a Delaware limited liability company ("Assignor"), in favor of Small Town Brewery, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor is the owner of the trademarks, trademark applications and registrations for the trademarks and common law rights set forth on Schedule A hereto (the "Assigned Trademarks");

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), pursuant to which, among other things, Assignor has agreed to assign to Assignee the Assigned Trademarks; and

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to accept from Assignor, all right, title and interest of Assignor in and to the Assigned Trademarks.

NOW, THEREFORE, in consideration of the mutual promises and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignment. Effective as of the date hereof, Assignor sells, transfers, assigns and delivers to Assignee, and Assignee purchases, accepts and assumes from Assignor, all of Assignor's right, title and interest in and to the Assigned Trademarks, including any and all associated: (i) goodwill symbolized thereby; (ii) business associated with and represented by the Assigned Trademarks; (iii) common law rights associated with the Assigned Trademarks, as well as any applications or registrations associated with the Assigned Trademarks; (iv) rights to sue for past, present and future infringements, including the right to settle suits involving claims and demands for royalties owing; and (v) rights to assign the rights conveyed herein, the same to be held and enjoyed by Assignee for its own use and benefit, and for the benefit of its successors, assigns and legal representatives.

2. Successors and Assigns. This Assignment shall be binding upon the parties and their permitted successors and assigns.

3. Governing Law. This Assignment shall be governed and controlled as to validity, enforcement, interpretation, construction, effect and in all other respects by the laws of the State of New York, without reference to its principles of conflicts of laws that would require application of the substantive laws of any other jurisdiction.

4. Counterparts. This Assignment may be executed by counterpart signature, each of which signature shall be deemed an original and all of which counterparts together shall constitute one in the same instrument. Furthermore, delivery of a copy of such signature by

electronic transmission shall constitute a valid and binding execution and delivery of this Assignment by such party, and such electronic copy shall constitute an enforceable original document.


