**SUPPLEMENT NO. 12 TO TRADEMARK SECURITY AGREEMENT**

Effective as of December 31, 2014

**BELKIN INTERNATIONAL, INC.**, a Delaware corporation (“Debtor”), with offices located at 12045 East Waterfront Drive, Playa Vista, CA 90094, hereby acknowledges that it has granted to **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, as collateral agent (in such capacity, together with its successors and assigns in such capacity, “Agent”) for the Secured Parties (as such term is defined in the Agreement) defined below)) with offices located at 2450 Colorado Avenue, Suite 3000W, Santa Monica, CA 90404, a security interest in and to all of Debtor’s right, title and interest in and to the trademarks and trademark registrations and applications therefor which are identified on Schedule I attached hereto and herein incorporated by this reference owned by Debtor (the “Trademarks”), together with the goodwill and assets of the business, as set forth in the Agreement.

The terms and conditions of the aforementioned security interest are contained in that certain Trademark Security Agreement dated as of March 6, 2012 (the “Agreement”) by and between Debtor and Agent (which was executed by the predecessor Agent, Wells Fargo Capital Finance, LLC, a Delaware limited liability company), and which was recorded in the United States Patent and Trademark Office (“USPTO”) on March 9, 2012 as Reel and Frame No. 004732/0366, as security for the obligations as set forth in the Agreement and any other agreements referred to therein. Nothing contained in this Supplement No. 12 to Trademark Security Agreement shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Agent or Secured Parties may have in any other collateral described in the Agreement, the prior supplements heretofore delivered, or otherwise.

Schedule I attached hereto in intended to supplement the original Schedule I which was attached to the Agreement and recorded with the USPTO, and each Schedule I to all of the supplements heretofore delivered.

THIS SUPPLEMENT NO. 12 TO THE AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF CALIFORNIA.


