**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement (this "Release") is made as of the 31st day of July, 2015 by Medley Capital Corporation, a Delaware corporation ("Medley"), as collateral agent for the benefit of the Secured Parties pursuant to the Intellectual Property Security Agreement dated as of November 26, 2013 (the "Security Agreement"), which termination and release is in favor of Marine Accessories Corporation, an Arizona corporation, Monster Marine Products, Inc., a Delaware corporation, Great Lakes Boat Top LLC, a Delaware limited liability company, and Xtreme Marine Corporation, a Delaware corporation (collectively, "Grantors"), as Grantors in the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Medley does hereby absolutely, unconditionally, irrevocably and forever release, cancel, discharge and terminate any and all pledges, encumbrances, hypothecations and security interests granted by each and every Grantor to Medley pursuant to the Security Agreement in: (i) all Patents (as defined in the Security Agreement), including without limitation those patents and patent applications described in the attached Schedule A recorded in the U. S. Patent and Trademark Office on November 26, 2013 at Reel/Frame 31731/385, Reel/Frame 31731/460, Reel/Frame 31731/409, Reel/Frame 31731/450, and Reel/Frame 31731/470 and (ii) the Trademarks (as defined in the Security Agreement, including without limitation those trademark applications and registrations described in the attached Schedule B recorded in the U. S. Patent and Trademark Office on November 26, 2013 at Reel/Frame 5162/349; (iii) all Copyrights (as defined in the Security Agreement); (iv) all reissues, divisions, continuations, continuations in

part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of Grantor accruing thereunder or pertaining thereto; (v) any and all claims for damages or injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing; and (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral (as defined in the Security Agreement) of or arising from any of the foregoing. (collectively, the "Released Intellectual Property");

Medley hereby absolutely, unconditionally, irrevocably and forever terminates the Security Agreement and any other agreement under which Grantors have granted a pledge, encumbrance, hypothecation, grant, assignment, lien or security interest under the Released Intellectual Property.

Medley hereby authorizes the recordation of this Release with the United States Patent and Trademark Office.

From time to time after the date hereof, at the request of Grantors or their assignees, Medley and its assignees shall execute and deliver to such requesting party such documents and take such other actions as such requesting party may reasonably request and reasonably require in order to carry out and fulfill the purposes and intent of this Release.
