TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of July 31, 2015 by **BANK OF AMERICA, N.A.** (as successor in interest to Fleet National Bank (f/k/a BankBoston, N.A. (f/k/a The First National Bank of Boston))), as agent or collateral agent (in each such capacity, the "*Agent*"), in favor of **GREATER PARK CITY COMPANY**, a Utah corporation ("*GPCC*"), **BOREAL RIDGE CORPORATION**, a California corporation ("*Boreal*"), **MT. BACHELOR LLC**, an Oregon limited liability company (as successor by conversion to Mt. Bachelor, Inc., an Oregon corporation) ("*Bachelor*"), **KILLINGTON/PICO SKI RESORT PARTNERS, LLC**, a Delaware limited liability company (as successor by merger to each of MTB Killington, LLC, a Delaware limited liability company, AMSC Killington, LLC, a Delaware limited liability company, and SP II Resort LLC, a Delaware limited liability company) ("*KSRP*"), and **POWDR - COPPER MOUNTAIN LLC**, a Delaware limited liability company ("*Copper*"), and together with GPCC, Boreal, Bachelor and KSRP, individually, a "*Grantor*", and collectively, the "*Grantors*").

WHEREAS, GPCC executed and delivered a Trademark Collateral Security and Pledge Agreement dated as of May 12, 1994 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Original Trademark Agreement*"), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the Original Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 18, 1994, at Reel 1159, Frame 0084;

WHEREAS, GPCC executed and delivered an Amended and Restated Trademark Collateral Security and Pledge Agreement dated as of May 30, 1998 ("*A&R Trademark Security Agreement*"), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the A&R Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 21, 1998, at Reel 1803, Frame 0223;

WHEREAS, GPCC executed and delivered a First Amendment to Amended and Restated Trademark Collateral Security and Pledge Agreement dated as of October 31, 2001 ("*First Amendment to A&R Trademark Security Agreement*") granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the First Amendment to A&R Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 2, 2002, at Reel 2418, Frame 0816;

WHEREAS, certain of the Grantors, among others, executed and delivered a Master Amended and Restated Intellectual Property Collateral Security and Pledge Agreement dated as

of May 10, 2007 ("*Master A&R IP Security Agreement*") granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the Master A&R IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 29, 2008, at Reel 3729, Frame 0798;

WHEREAS, the Grantors, among others, executed and delivered a Joinder, First Amendment and Confirmation of Master Amended and Restated Intellectual Property Collateral Security and Pledge Agreement dated as of December 18, 2009 (the "*First Amendment to Master A&R IP Security Agreement*", and, together with the Master A&R IP Security Agreement, the First Amendment to A&R Trademark Security Agreement, the A&R Trademark Security Agreement, and the Original Trademark Agreement, collectively, the "*Grants*") granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the First Amendment to Master A&R IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 30, 2009, at Reel 4121, Frame 0655; and


