RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of August 7, 2015, is executed by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, “Agent”), in favor of HARVEST MEAT COMPANY, INC., a Delaware corporation (“Harvest”), HAMILTON MEAT, LLC, a California limited liability company (“Hamilton”), WESTERN BOXED MEATS DISTRIBUTORS, INC., an Oregon corporation (“Western”), SURFLINER HOLDINGS, INC., a Delaware corporation (“Parent”), SAND DOLLAR HOLDINGS, INC. a Delaware corporation (“Sand Dollar”), and CASCADE FOOD BROKERS, INC., an Oregon corporation (“Cascade” and together with Harvest, Hamilton, Western, Parent, and Sand Dollar, each a “Grantor” and together, the “Grantors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantors have, pursuant to a Trademark Security Agreement dated July 30, 2012, recorded in the United States Patent and Trademark Office on July 31, 2012 at Reel 4832, Frame 0222, (the “Trademark Security Agreement”), granted to Agent (for the benefit of each member of the Lender Group and the Bank Product Providers) a Security Interest in and to all of the Grantors’ right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, wishes to release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, hereby releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of the Grantors. The Agent authorizes the Grantors and their designees to record this Release with the United States Patent and Trademark Office and other applicable registry at the sole expense of the Grantors and agrees to provide Grantors with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.







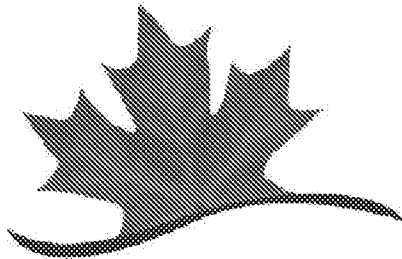
