**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of August 26, 2015, and made by Credit Suisse AG, in its capacity as collateral agent pursuant to the Security Agreement referred to below (in such capacity, the "Collateral Agent") to KIK New Jersey, LLC, a Delaware limited liability company, whose principal place of business is 909 Magnolia Avenue, Auburndale, Florida 33823 (the "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to Collateral Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on June 4, 2013, at Reel 005040 and Frame 0418; and

WHEREAS, the Collateral Agent now desires to terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, Collateral Agent hereby states as follows:


1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Second Lien Security Agreement ("Security Agreement"), dated as of May 23, 2013, made by, *inter alios*, the Grantor in favor of Collateral Agent.

2. Release of Security Interest. Collateral Agent hereby terminates the Interests and terminates, releases and discharges its collateral pledge, grant, assignment, lien and security interest in the Trademarks, without recourse, representation or warranty.
