RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of August 18, 2015 ("Effective Date") by The Bank of New York Mellon Trust Company, N.A., as Collateral Agent (the "Collateral Agent") and Grantee, in favor of Boasso America Corporation, a Louisiana corporation ("Grantor").

WHEREAS, Grantor, the Collateral Agent and the other parties thereto entered into that certain Collateral Agreement, dated as of November 3, 2010 (as amended, modified, restated and/or supplemented from time to time, the "Collateral Agreement"), which required the Grantor and the Collateral Agent to enter into the Trademark Security Agreement (defined below);

WHEREAS, Grantor and the Collateral Agent entered into that certain Grant of Security Interest in United States Trademarks (the "Trademark Security Agreement"), to record the security interest in (i) all of Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the business with which the Marks are associated and (iv) all causes of action arising prior to or after the date thereof for infringement of any of the Marks or unfair competition regarding the same (collectively, the "Trademark Collateral"), and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2010 at Reel 4309, Frame 0721;

WHEREAS, Grantor has satisfied the terms of the Collateral Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement and releases and re-assigns to Grantor, without recourse, representation or warranty, any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
