**RELEASE OF RIDER TO AMENDED AND RESTATED  
SECURITY AGREEMENT-TRADEMARKS**

**THIS RELEASE OF RIDER TO AMENDED and RESTATED  
SECURITY AGREEMENT-TRADEMARKS** (this “**Release**”) is dated on  
JULY 14<sup>th</sup>, 2015, by PNC BANK, NATIONAL ASSOCIATION (the “**Bank**”).

**BACKGROUND**

A. Ballet Maker, Inc. (“**Grantor**”) executed and delivered to Bank that certain Amended and Restated Security Agreement-Trademarks dated as of May 15, 2003, as amended by (i) that certain First Amendment to the Rider to Amended and Restated Security Agreement-Trademarks dated as of July 21, 2009, (ii) that certain Second Amendment to the Rider to Amended and Restated Security Agreement-Trademarks dated as of December 10, 2009, (iii) that certain Third Amendment to the Rider to Amended and Restated Security Agreement-Trademarks dated as of August 29, 2012, (iv) that certain Fourth Amendment to the Rider to Amended and Restated Security Agreement-Trademarks dated as of April 30, 2014, and (v) that certain Fifth Amendment to the Rider to Amended and Restated Security Agreement-Trademarks dated as of January 29, 2015, but effective as of December 31, 2015 (collectively, the “**Security Agreement**”), which granted to Bank a lien and security interest in and to all of the Grantor’s Trademarks, together with all the goodwill and other tangible assets of the Grantor associated with and represented by the Trademarks, and the non-intent to use applications for and registration thereof, including without limitation, license royalties and proceeds of infringement suits, as more particularly defined and described in the Security Agreement (the “**Trademark Collateral**”) as security for some or all of the Grantor’s obligations to the Bank for one or more loans or other extensions of credit.

B. The Amended and Restated Security Agreement-Trademarks, dated as of May 15, 2003 was recorded in the United States Patent and Trademark Office on June 11, 2003, in Reel 2752, Page 601. The First Amendment to Rider to Amended and Restated Security Agreement-Trademarks, dated as of July 21, 2009, was recorded in the United States Patent and Trademark Office on July 23, 2009, in Reel 4030, Page 964. The Second Amendment to Rider to Amended and Restated Security Agreement-Trademarks, dated as of December 10, 2009, was recorded in the United States Patent and Trademark Office on July 21, 2010, in Reel 4246, Page 444. The Third Amendment to Rider to Amended and Restated Security Agreement-Trademarks, dated as of August 29, 2012, was recorded in the United States Patent and Trademark Office on September 4, 2012, in Reel 4855, Page 0209. The Fourth Amendment to Rider to Amended and Restated Security Agreement-Trademarks, dated as of April 30, 2014, was recorded in the United States Patent and Trademark Office on May 7, 2014, in Reel 5275, Page 0488. The Fifth Amendment to Rider to Amended and Restated Security Agreement-Trademarks, dated as of January 29, 2015, but effective as of December 31, 2014, was recorded in the United States Patent and Trademark Office on February 2, 2015, in Reel 5458, Page 0383.

The undersigned, on behalf of the Bank, hereby certifies as follows:

1. The non-contingent obligations secured by the Trademark Collateral have been paid in full and the security interests granted by the Grantor to the Bank in the Trademark Collateral may now be released. The Bank hereby releases its security interests in and liens on the Trademark Collateral described in and created by the Security Agreement. The Security Agreement may now be released of record.
