IN PATENTS AND TRADEMARKS**





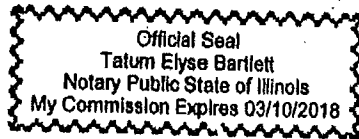
