**NOTICE OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

**August 3, 2015**

**WHEREAS**, Triangle Tool Corporation, a Wisconsin corporation (the "**Grantor**"), having its chief executive office at 8609 West Port Avenue, Milwaukee, Wisconsin 53224, is the owner of all right, title and interest in and to certain United States trademarks and trademark applications;

**WHEREAS**, BMO Harris Bank N.A., a national banking association, having an office at 770 N. Water Street, Milwaukee, WI 53202 ("**Bank**"), has acquired a security interest in all of the Grantor's right, title and interest in and to the Grantor's trademark and trademark applications and other collateral as described below; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions of the Amended and Restated Credit Agreement dated as of the date hereof, among Grantor and Bank (as amended, restated, supplemented or otherwise modified from time to time, the "**Amended and Restated Credit Agreement**"), and the Security Agreement dated as of the date hereof among Grantor and Bank, the Grantor has granted and hereby grants Bank a continuing security interest in all of the Grantor's right, title and interest in and to the following, whether now or hereafter existing, arising or acquired: (i) United States trademarks and trademark applications (the "**Trademarks**"), including without limitation those set forth on Schedule A, (ii) all reissues, extensions or renewals of any Trademarks, (iii) all causes of action arising prior to, on or after the date hereof for infringement of any Trademark and (iv) all proceeds of, and rights associated with, the foregoing.

The rights and remedies of Bank with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in, the Amended and Restated Credit Agreement and the Security Agreement, the terms and provisions of which are incorporated herein by reference. If any provision of this Agreement conflicts with the Amended and Restated Credit Agreement or the Security Agreement, the provisions of the Amended and Restated Credit Agreement and the Security Agreement shall govern.




