## RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARK ("Release"), effective as of this the 24 th day of September, 2015, is made by Bank of America, N.A., a national banking association as the Security Agent ("Security Agent"), in favor of SPi Technologies, Inc., a company incorporated in the Philippines ("Grantor").

**WHEREAS**, Grantor is a party to an Intellectual Property Security Agreement dated September 9, 2013 (as may have been amended, modified, supplemented, increased, extended, or restated from time to time, hereinafter the "I.P. Security Agreement"), under which Grantor granted to Security Agent, for the benefit of the Secured Parties (as defined in the Facilities Agreement between the parties hereto, dated March 27, 2013, and as amended and restated on May 14, 2013), a priority security interest in and to all of Grantor's right, title and interest in and to all Intellectual Property Collateral (as defined in the I.P. Security Agreement), including trademarks, service marks, logos, names, trademark registrations and trademark applications and any renewals thereof, including without limitation those set forth on Schedule A attached hereto (individually and collectively, the "Trademark");

**WHEREAS**, the I.P. Security Agreement was recorded at the U.S. Patent and Trademark Office on September 12, 2013 at Reel 5109, frame 0347;

**WHEREAS**, Grantor and Security Agent have terminated the I.P. Security Agreement and all security interests, liens and encumbrances relating to the Trademark in accordance with Section 9.3(b) of the Security Agreement through the execution of the Stock Purchase Agreement dated August 11, 2014; and

**WHEREAS**, Security Agent wishes to release to Grantor and to dissolve any and all security interests, liens and encumbrances created by the I.P. Security Agreement with respect to the Trademark; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confirmed, Security Agent, on behalf of itself and the Secured Parties, does hereby, fully and finally release and relinquish all security interests, liens and encumbrances in the Trademark granted to Security Agent by Grantor, including, without limitation, all of Security Agent's security interests, rights, common law rights, title, and interest in the names, trademarks, service marks, trademark applications and registrations granted pursuant to the I.P. Security Agreement, and identified in Schedule A hereto, and the goodwill of the business symbolized by and associated therewith.


