NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of September 30, 2015, by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors, "Secured Party") to **KPAQ INDUSTRIES, LLC**, a Louisiana limited liability company (the "Grantor").

WHEREAS, on June 17, 2014, the Grantor and the Secured Party entered into a Revolving Credit and Security Agreement (the "Credit Agreement") in order to secure the payment and performance of the Obligations in accordance with the terms and conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, the Grantor was required to execute and deliver the Patent and Trademark Security Agreement dated as of June 17, 2014 (the "Security Agreement") to the Secured Party;

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Secured Party, among other collateral as set forth therein, a continuing security interest in all of the Grantor's right, title and interest, in, to and under the IP Collateral (as defined in the Security Agreement), including the United States Trademark listed on the attached Schedule A (the "Mark"); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 18, 2014 at Reel/Frame 5304/0185;

WHEREAS, Secured Party wishes to release its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases, discharges and remits, without any recourse, representation or warranty, any security interest in and lien upon the IP Collateral, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the IP Collateral that the Security Agent may hold. The Secured Party hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.
