## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of September 30, 2015, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, "Agent"), in favor of ONFOCUS HEALTHCARE, INC., a Delaware corporation (as "Grantor"). 
B. WHEREAS, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, wishes to release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, hereby releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Agent authorizes the Grantor to record this Release with the United States Patent and Trademark Office and other applicable registry at the sole expense of the Grantor and agrees to provide Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
