**CONFIRMATION OF**  
**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This CONFIRMATION OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Confirmation") is executed and delivered as of the 5th day of October, 2015 by Wells Fargo Bank, National Association, a national banking association ("Wells Fargo"), in its role as Administrative Agent under the Loan Agreement (defined below), to Tropicana Las Vegas, Inc., a Nevada corporation (the "Company").

**BACKGROUND**

A. Pursuant to that certain Loan Agreement dated as of March 17, 2010 (the "Loan Agreement"), among the Company, the lenders thereto (collectively, the "Lenders") and Wells Fargo, as successor to The Foothill Group, Inc., as Administrative Agent (the "Agent"), as amended by that certain First Amendment to Loan Agreement dated as of April 26, 2011, as further amended by that certain Second Amendment to Loan Agreement and Limited Duration Waiver dated as of August 26, 2011, and amended and restated by that certain Amended and Restated Loan Agreement dated as of December 21, 2012, the Company entered into that certain Trademark Security Agreement dated as of May 14, 2010 and that certain First Amendment to Trademark Security Agreement dated as of November 9, 2011 (collectively, the "Security Agreement").

B. Pursuant to the Security Agreement, the Company granted the Agent a security in its trademarks, including those registrations and pending applications with U.S. Patent and Trademark Office ("US PTO") set forth on Exhibit A, which was prepared by the Company and is attached hereto and made a part hereof, and said security interests were recorded with the US PTO at Reel/Frame 4207/0627 and Reel/Frame 4679/0742.

C. On August 25, 2015, the Company's obligations under all of the Loans (as defined in the Loan Agreement) were paid in full, and terminated all respective commitments of the Agent and the Lenders governed by, the Loan Agreement, in accordance with that certain letter agreement of even date therewith by and among Wells Fargo, the Company and the other parties thereto (the "Letter Agreement").

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby:

1. In accordance with and subject to its rights under the Letter Agreement and the Loan Agreement, the Agent hereby confirms the termination and release of all of its right, title and interest in the trademarks described in the Security Agreement, including those set forth on Exhibit A.

2. The Company, or its designee, may record this Confirmation in the US PTO and in any other trademark offices as may be necessary to carry out the intentions of this Confirmation.

3. The Agent agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, in each case without recourse, to carry out the intentions of this Confirmation, solely at the request and expense of Company.


