## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "**Release**") is made effective as of September 29, 2015, by Bank of America, N.A. ("**Bank of America**"), as Agent (the "**Agent**") for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Alliant Techsystems Inc.; Ammunition Accessories Inc.; ATK Commercial Ammunition Company Inc.; ATK Commercial Ammunition Holdings Company Inc.; ATK Launch Systems Inc.; ATK Space Systems Inc.; Federal Cartridge Company; and Micro Craft Inc. (collectively, the "**Grantors**").

WHEREAS, Alliant Techsystems Inc., a Delaware corporation, has entered into an Amended and Restated Credit Agreement dated as of March 29, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), with Bank of America, N.A., as Agent, and the other Agents and the Arrangers party thereto. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement;

WHEREAS, as a condition precedent to the making of Loans by the Lenders and the issuance of Letters of Credit by the L/C Issuers under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, each Grantor has executed and delivered that certain Amended and Restated Security Agreement dated March 29, 2007 made by the Grantors to the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**");

WHEREAS, under the terms of the Security Agreement, the Grantors entered into that certain Intellectual Property Security Agreement, dated as of March 29, 2007 (the "**IP Security Agreement**") whereby the Grantors granted to the Agent a security interest in and to certain intellectual property of the Grantors;

WHEREAS, that certain IP Security Agreement, dated as of March 29, 2007, was recorded with the United States Patent and Trademark Office on August 24, 2007 at Reel 19733 and Frame 757 with respect to U.S. patents and patent applications, and at Reel 3608 and Frame 342 with respect to U.S. trademarks and trademark applications;

WHEREAS, that certain IP Security Agreement Supplement, dated as of April 24, 2009, was recorded with the United States Patent Trademark Office on September 24, 2009 at Reel 23275 and Frame 412 with respect to U.S. patents and patent applications, and at Reel 4067 and Frame 0351 with respect to U.S. trademarks and trademark applications;

WHEREAS, that certain IP Security Agreement Supplement, dated as of July 5, 2009, was recorded with the United States Patent Trademark Office on November 4, 2009 at Reel 23470 and Frame 391 with respect to U.S. patents and patent applications, and at Reel 4091 and Frame 80 with respect to U.S. trademarks and trademark applications; and

WHEREAS, in accordance with the provisions of the IP Security Agreement, the Agent now desires to release its security interest in and to the Collateral (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Agent hereby releases to the Grantors its security interest in all of the Grantors' right, title and interest in and to the following (the "*Collateral*");

- (i) all patents and patent applications set forth in Schedule A hereto (the "*Patents*");
- (ii) all trademarks, service marks, domain names, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers, whether registered or unregistered set forth in Schedule B hereto, together, in each case, with the goodwill symbolized thereby (the "*Trademarks*");
- (iii) all copyrights, whether registered or unregistered, now owned or hereafter acquired by Grantors, including, without limitation, the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto (the "*Copyrights*");
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of Grantors accruing thereunder or pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing; and
- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.


